1. VOLUNTEER MOTIVATIONAL/INSPIRATIONAL MESSAGE

Mayor Henderson asked if anyone would like to give a motivational or inspirational message. Mayor Henderson stated he would like to offer a motivational message in the form of a prayer.

2. INVITATION TO SAY PLEDGE OF ALLEGIANCE

Mayor Henderson invited those who would wish to participate, to stand and say the pledge of allegiance with him. He then led the pledge of allegiance for those who wanted to participate.

3. STORM DRAIN INTERLOCAL AGREEMENT

It was stated that this is an interlocal agreement with Utah County. This agreement was passed back in 2004, and this is a continuation of the agreement. Bruce ward stated that

the funds from this go towards educating the communities. Salem City portion is \$1,397. Some of the other programs are letting people know where they can take old oil and other liquids that get put in Storm Drains. The TV campaign "We all live down stream" also promotes this. Bruce also stated that the benefit from this is that we act as a group, rather than individual cities.

4. SUNRISE ENGINEERING

a. Amendment #1

Bruce Ward stated that this amendment is allowing Sunrise Engineering to do General Engineering work for the city. The last agreement expired in December of 2007.

b. Work Release # 7

Bruce stated that this work release is for the SCADA system for the PI. It was in the budget for PI construction, we just did not award it to anyone. Sunrise will be able to do it for \$56,000.

Mayor Henderson stated that he would like to make a special presentation to members of the Ambulance, Fire, and Police Departments, who took part in responding to an accident and helped rescue an individual who was stuck under a vehicle in a wetland area of a field. They had to lift the vehicle off of the individual without any equipment because he was drowning.

5. Eagle Scout Projects

a. Trevor Williams – Painting Fire Hydrants

Trevor was not present.

b. Tyler Huff - Cleaning Cemetery Headstones.

Tyler Huff stated that he has been working with Erman Stone, who takes care of the cemetery, to clean off the headstones. He would like to clean off the headstones by cleaning the weeds, the dirt, and other debris around the headstones. He feels it would be very beneficial for the city, and the cemetery. He will be working with scouts in his troop.

The council felt that it would be a good project.

10. OPEN DISCUSSION

Mayor Henderson asked if anyone had anything for open discussion. Wes Jenkins was wondering about the PI and if the city puts on restrictions because of abuse. He stated that if he was an abuser of the system he would understand, but for those who do not abuse it, and who try to conserve, he feels that it would be unfair to them to put

restrictions. Bruce Ward stated that the restrictions that may be imposed would be watering according to address, or something to that affect. We are also looking at ways that we maybe able to get some grant money from the water district, to help the city residents conserve water.

Mayor Henderson stated that this is the first year, and we need to educate our residents.

There was a question about when the PI water will be turned off. Bruce Ward stated that usually the middle of October is when the canal will shut off. If the city needs to, it can use culinary water to fill up the PI Ponds.

Mayor Henderson stated that it has been decided to not hold a flag raising ceremony this Forth of July.

He also reported that Salem Days is going very well.

12. COUNCILPERSON LYNN DURRANT

Councilperson Lynn Durrant stated that Anthony Bowden is the coach for the 9th grade football team. They are in need of equipment, since this is the first year doing 9th grade football. We need all of the equipment for about 35 players. There was some money donated to the recreation department, and we feel that this would be a good purchase for the donations. It will cost about \$10,000 for all of the equipment, which will use up the remaining amount of the donation. She thanked Anthony for his hard work and getting this program in place.

Councilperson Durrant explained a game that will be played at the library auction called "heads and tails". She stated that winner will be receiving a scooter from Sequoia Motors. Councilperson Todd Gordon stated he would work on getting the scooter.
