Minutes of the Salem City Council Meeting held on October 6, 2010 in the Salem City Council Chambers.

Work Session: 6:30 p.m. Floyd Rigby and Bruce Rigby owners of Utility Cost Management Consultants talked to the city council about power rates for larger users such as the High School. They stated that they have been working with Nebo School District on options to help save money on utilities. One recommendation was to look at putting the school on a new rate structure, maybe putting them on an industrial power rate.

Mayor Cope explained what an industrial user is, and how they use the power during off peak hours, and reported that the school would not qualify for an industrial user.

Floyd explained that they have a contract with the state for the services to help entities see how they are using energy and how they are billed for utilities. They would like the city to look at possibilities to work with Nebo if possible; they would also like to meet with representatives from the city to further discuss this. They will be contacting Bruce Ward and Attorney Junior Baker to discuss options.

Mayor Cope explained that a new fire chief and a new treasurer have been selected for the city. Clyde McKean was the prior fire chief and has resigned; we appreciate all that he has done. The new fire chief that has been selected is Jim Ealey. Jim has served in the fire department and ambulance association; he has also served as ambulance captain for the city. Jane Topham is the city's current treasurer; she will be retiring on November 15. Tammy Beck has been selected to be the city's new treasurer. Her appointment will not take effect until November 15, following Jane's retirement.

## 4. YOUTH COUNCIL REPORT

Mike Christensen reported on the youth council. He stated that they cleaned around the pond in September, they got some boats and cleaned some areas that were hard to get, and also used a back hoe that was operated by a city employee. They helped with the Mt. Loafer Elementary School fall carnival. Their webpage has been updated, and anyone

can check it out. A link is on the city's web page. At the end of the month, they will be doing a training retreat in Salt Lake City. Also at the end of October they will be doing the trick or treat at the park on October 30.

# 5. AWARD ENERGY AUDIT PROPOSAL

Bruce Ward reported that a few months ago we applied for an energy efficiency grant through the Department of Natural Resources. We applied for several items, funds to perform an energy efficiency and sustainability master plan, as well as funds to install solar power generation at the city office and at the wastewater treatment plant. We were awarded \$40,000 to perform the energy master plan.

Several weeks ago we advertised for proposals and asked interested firms to propose a scope of work that they could complete for \$40,000. We outlined our general expectations in the RFP. We received proposals from four companies, Forsgren Associates, Inc; Aqua Engineering; Weber Sustainability Consulting; Gardner Engineering Alternative Energy Services. The proposals have been reviewed by Councilperson Durrant, Mayor Cope, Clark Crook and himself. After reviewing them, it was proposed that the bid to be awarded to Gardner Engineering. In the study they will do an audit of the city facilities, and give us ideas of how to better use energy and help with future facilities for the city.

# 6. APPROVE SUPPLEMENTAL AGREEMENT WITH UDOT FOR SAFETY SIDEWALK FROM 640 N. TO 750 N. SR 198

Bruce Ward reported that back on July 7<sup>th</sup>, the city approved an agreement with UDOT for a safety sidewalk grant. The city was awarded \$10,000 for the sidewalk. When the bids came back on the project, they came back at \$25,000, which is more than what we were awarded. Bruce stated that he reported that to UDOT and asked for more money. UDOT stated that they would give us the money needed. The grant is a matching grant of 15%, and most of the city's participation will be done with in-kind services. Tonight we need to ratify the mayor's signature. UDOT brought the agreement in the other day when the Mayor was in the office, so we had him sign it then so we could get going on the project.

# 7. APPROVE SPECIAL USE PERMIT BY UTAH DEPARTMENT OF ALCOHOLIC BEVERAGES CONTROL FOR NEWAYS INTERNATIONAL

Jeff Nielson explained that Neways needs to get a permit from the Utah Department of Alcoholic Beverages Control for the use of Ethel Alcohol. They will have less than four liters in the building, and will use less than four millimeters when they use it. They will be using the alcohol for testing purposes, and it will be disposed of as hazardous material. They have been working with the public safety to make sure everything is stored and used correctly. Attorney Baker stated that the portion of the State Code that currently requires Neways to get the permit will be taken out of the state code on July 1, 2011.
