1. WELCOME

Attorney Randall Feil, Salem City RDA, stated that the city has created a Community Development Area. The five acres of property the city just transferred to the RDA, will be the Community Development Area.

The minutes should show that this is the time and the date set for a public hearing on the Salem North Community Development Project Area and Project Area Plan and for public comment, conducted by the Salem City Redevelopment Agency on Wednesday, November 7, 2007 at 7:00 p.m. in the City Council Chambers, Salem City Hall, 30 West 100 South, Salem, Utah, pursuant to Notice. The purposes of this public hearing are to:

(1) Allow public comment on the draft Salem North Community Development Project Area Plan (the "Project Area Plan") for the Salem North Community Development

Project Area (the "Project Area");

- (2) Allow public comment on whether the draft Project Area Plan should be revised, adopted or rejected; and
- (3) Receive all written objections and hear all oral objections to the draft Project Area Plan.

The following documents, along with their related certificates or affidavits of mailing, proofs of publication, etc., will be made part of the public hearing record:

- 1. A Notice of Public Hearing as required by the Community Development and Renewal Agencies Act, Title 17C, Parts 1 through 4, Utah Code Annotated 1953 as amended (the "Act"), Sections 17C-4-401 and 402, Utah Code Annotated, which was published on October 15, 2007 in the Daily Herald Newspaper.
- 2. The Redevelopment Agency Resolution 9-19-07 dated the 19th day of September 2007 authorizing the preparation of a draft project area plan, as provided by Section 17C-4-1O1 of the Act.
- 3. A Notice executed by the Redevelopment Agency which was mailed to: (a) each owner of record owning property within the boundaries of the proposed Project Area; (b) each taxing entity having the power to levy a tax within the boundaries of the proposed Project Area.
- 4. The draft Community Development Project Area Plan entitled, "Salem North Community Development Project Area Plan" containing the provisions required by the Act, which draft Plan has been available for public inspection at the office of the Redevelopment Agency since at least October 1, 2007. Copies of said Plan are also available at this hearing and may be reviewed by interested parties.
- 5. The Agenda of this meeting and the Notice of Meeting which has been given as required by Section 52-4-6, Utah Code Annotated.

The Redevelopment Agency is holding this public hearing pursuant to the provisions of

Section 17C-4-402(1)(e)(1) of the Act which reads as follows:

- "(1) In order to adopt a project area plan, after adopting a resolution under Subsection 17C-4-101 the agency shall:
- (e) hold a public hearing on the draft project area plan and, at that public hearing:
- (I) allow public comment on:
- (A) the draft project area plan; and
- (B) whether the draft project area plan should be revised, approved, or rejected."

The public record should reflect that at the time of commencement of this public hearing, the Redevelopment Agency had received no objections to the Project Area Plan. The Agency will consider any oral or written objections to the adoption of the draft Community Development Project Area Plan which may be made or presented at this hearing.

A. Explanation of Purposes of the Public Hearing – Randall Feil

Attorney Randall Feil explained the purposes of the public hearing prior.

B. Review of Salem North Community Development Project Area Plan – Junior Baker & Randall Feil.

Attorney Randall Feil, reviewed the Project Area Plan. He stated that it contains the legal description, a map of the area, the land use (the property is currently vacant and being farmed), layout of principal streets in the project area, population, building intensities in the project area (this is raw land at the moment). It sets the standards, how it will fit in with the general plan, will follow building codes, and work with planning & zoning. There is an analysis of the project, and states that the city is working with a grocery store. The plan gives the agency a flexibility to work with business to bring them to the city.

It was stated that there is not. Katie asked what the property will be used for. Mayor Henderson stated that the city is working with a grocery store, and would like to see it there.

- C. Be economically sound and feasible; it is expected that the private sector will perform required construction and installation relating to projects, and any related funding from the Agency will be by way of grants received by the Agency;
- D. Conform to Salem City's general plan, because the Plan provides that all development in the Project Area is to be in accordance with the City's zoning ordinances and requirements;
 - E. Promote the public peace, health, safety and welfare of Salem City.
